ORDER

WHEREAS regulation 2.3.4 of the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulation, 2011 made by the Food Safety and Standard Authority of India in exercise of the powers conferred by Clause(i) of sub-section (2) of Section 92 of the Food Safety and Standards Act, 2006 (Central Act 34 of 2006 read with Section 26 thereof, prohibits the use of tobacco and nicotine as ingredients in any food products.

AND WHEREAS, Gutka and Pan Masala, Masheri & Khaini are articles of food in which tobacco and nicotine are widely used as ingredients now-a-days.

AND WHEREAS, it is expedient to prohibit the manufacture, sale and distribution of Gutka and Pan Masala in the State of Himachal Pradesh being food products in which tobacco and nicotine are widely used as ingredients.

Therefore, in view of provisions of Regulation 2.3.4 of Food Safety & Standards Act, 2006, storage, sale or distribution of Gutka, Pan Masala, Masheri, Khaini becomes illegal and such food products, if stored, or being manufactured or sold in the State, the persons doing so will be proceeded against as per provisions of the Food Safety & Standards Act, 2006, read with Regulations cited aforesaid. Such food business operators should neither be registered nor issued a license for the same.

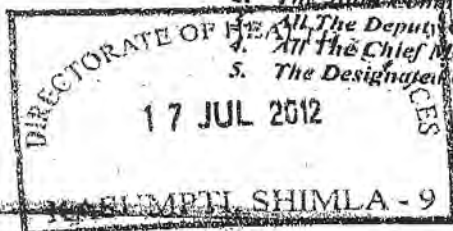

